Cranbrook Volunteer Coordinator Report:

Submitted by Judi Watson, Intake Coordinator for CBK December 10,2024

- Met with Brian Clarkson November 26 to discuss taking over as Intake coordinator for Cranbrook.
- Set out to make telephone contact with each volunteer on the volunteer clients list provided by Brian to introduce myself and confirm their status as a client facing volunteer and to confirm the clients they are working with.
- During these discussions discovered that several of the individuals on the volunteer list are no longer client facing volunteers.
- As of December 1, Cranbrook has 28 clients facing volunteers and 57 clients including the BSG (these numbers change regularly)
- Discovered that several clients do not have up to date intake forms on file in the office.
 These forms are critical for liability purposes and for potential gran applications, audits,
 etc. Each volunteer has been asked to ensure that they have a intake form on file for
 their client in the office.
- Confirmed that we as hospice cannot work officially with "anonymous clients"
- Worked with Karolyn to create a new improved spreadsheet of volunteers/client including intake date, volunteer name, email, phone number, current clients and relevant information. This spreadsheet will make it easier to keep track of everyone, both clients and volunteer needs.
- Question: How long should a client stay on our active list?

How long should a client stay on our active list?

This was discussed and due to the nature of our services it was decided indefinitely. We will continue to provide services as long as we are needed. The hope for bereavement clients is that we can step back after a year's time and that the client will be ok to see that happen. However as discussed, if our services are still required, we will continue to support them.

Volunteer Training Report:

Jeff Williams in attendance. Jeff posed the following questions and concerns to the board regarding our future online training for new volunteers.

- The online trainees need to provide verification that they understand the main teaching points?
- Some type of homework will need to submitted to verify their understanding of the content?
- The key teaching points need to be identified for each module and homework, quiz, etc submitted.
- Each module will need to be redesigned for online training, possibly short videos, etc may be more effective for online education?
- Other resources needed? Currently "With the End in Mind" by Dr. Kathryn Mannix is used, how would a student understanding be assessed online regarding the key teaching points.

Marla T and Karolyn are working together to edit the current primary training modules 1-3 to make them user friendly and relevant for online training. These are great questions as we work together to make the key points of each module important and valuable. Having future online training is new for us, we will know better over time through feedback if it is something that is valuable, efficient and useful to continue with.

Hospice House Update

Our anonymous donation of \$50,000 was deposited into our Hospice building account.

A steering committee is proposed by George. Strong community leaders and individuals are being approached that we are hoping to form our future Steering committee for our Hospice House. We hope to see the committee with 7-9 members. Once the committee has been formed, we will update the members to who is on the steering committee.
